

NFL's: Punt, Pass and Kick

Mr. Bauer will be hosting the NFL's Punt, Pass and Kick competition after school on **Monday October 3, 2016** at the Memorial Field. The competition is open to any student ages 6-15. There will be 4 age groups for both boys and girls; 6-7, 8-9, 10-11, 12-13. Age groups are determined by the participant's age as of December 31, 2016. **(Birth certificate is required for the winner of each age group).**

The competition times are as follows:

3:45-4:30 pm 6-7 and 8-9 yr. old boys and girls (scoreboard side of Memorial Field)
3:45-4:30 pm 10-11, 12-13 yr. old boys and girls (Far side of Memorial Field)

Since this will be done as an after school activity, the Parent Permission and Arrangements form must be completed and returned. Parents must also sign the Liability Waiver Form, as required by the PPK rules. Please return the 2 attached forms to Mr. Bauer prior to Oct. 3. **Students will not be able to participate if they do not turn in their forms.** The day of the event, the participants will gather in the gym at 3:15 pm. Mr. Bauer will escort the students to Memorial Field for warm up. The competition will begin at 3:45 pm. Parents are to meet at Memorial Field at 3:30. There will be a 15 minute warm up session. The competition will consist of: 1 throw, 1 punt and 1 place kick per contestant. The scores will then be totaled and the top scorer from each age group for boys and girls will move on to the Sectional Competition held in Indiana on October 15, 2016.

PPK rule: Students are NOT permitted to wear cleats for this event

PPK Entry Form and Release of Liability
